# Background

Lidl already have a store in Harlow at Staple Tye serving the south of the Town. Lidl would like to open a new store at Queensgate Centre to serve its customers to the north of the Town. The proposed new store will be in addition to its existing trading store. The vacant Toys R Us unit presents a unique opportunity to make the best use of existing retail floorspace to deliver the new store.

Queensgate Centre comprises a Decathlon, Currys PC World, Hobbycraft, Next Home, Cineworld Cinema, Pizza Hut, Chiquito and other shopping and associated facilities. Is is a very popular and well established shopping location in Harlow. The immediate surrounding is predominantly commercial in nature with a range of retail and employment uses focussed along Edinburgh Way (A14).

## The Proposal

Working with The Crown Estate, owners of Queensgate Centre, Lidl propose to re-furbish part of the vacant Toys R Us unit for a new store extending to 1,951 sqm gross internal area, with a net sales area of 1,100 sqm. The new store will feature an in-store bakery close to the main entrance. The introduction of a Lidl foodstore will complement the existing shopping offer at Queensgate Centre and provide food shopping choice at an established location.

The proposals include a new attractive glazed frontage and works to the existing car parking to the front (shared with Chiquitos) to include a total of 148 standard spaces, comprising 12 disabled and 15 Parent and Child spaces positioned close to the customer entrance. 12 cycle parking spaces are proposed.

Access to the store for customers will be via the existing access to Queensgate Centre from the main roundabout on Edinburgh Way. As is currently the case, service vehicles will share this access. Normally, there will be a maximum of only two HGV deliveries to the store per day. No works to the existing access are required for the scheme.

The Lidl proposals would create up to 40 new jobs, which Lidl would actively seek to recruit from the local area.

It is proposed that the store will be open between the hours of:

- 8am to 10pm Monday to Saturday (including Bank Holidays); and
- 10am to 4pm Sunday.

#### Benefits of the Proposed Development

The new Lidl store will provide the following benefits to the local area:

- A brand new store that will provide a clean and fresh shopping experience to meet the needs of customers;
- A dedicated in-store bakery;
- A contemporary building design that will complement the surrounding area;
- Re-use of a vacant retail unit to improve the economic vitality of the area;
- Employment opportunities for local residents; and
- Living Wage Foundation rate for all eligible employees and no zero hours contracts.


